APPLICATION

- SHAKE THE CONTAINER FOR 30 SECONDS BEFORE EACH USE
- Apply a generous coat with a garden sprayer, brush or roller
- Agitate with a stiff brush and leave for up to 8 hours depending on level of contamination before washing off
- Best results are achieved by cleaning off by using a power washer
- Repeat as necessary to achieve desired results
- Coverage dependent on porosity of paving

Precautions

- **Always test a small inconspicuous area before use to ensure surface compatibility, performance and finish is acceptable**
- Never mix or add any other cleaners or acid to the product
- Keep locked up and away from children
- Keep away from plants
- Keep away animals and pets until cleaning process is complete and surface is dry

Storage

- Store between 5°C and 25°C
- Store in a cool, well ventilated area. Keep container tightly closed
- Keep out of direct sunlight and protect from frost in original container
- Keep out of reach of children

Health & Safety

- Contains Sodium Hypochlorite
- Approved HSE BIOCIDE LICENCE NUMBER 9853
- Protect any surface or area not being treated
- Causes skin irritation and serious eye damage
- Will bleach most fabrics
- Harmful if swallowed
- Very toxic to aquatic life
- Wash hands thoroughly after handling
- Use only outdoors or in a well-ventilated area
- Do not breathe vapour
- Wear protective gloves/protective clothing/eye protection/face protection.
- **IF ON SKIN:** Gently wash with plenty of soap and water. Take off contaminated clothing and wash before reuse. If skin irritation or rash occurs seek medical advice/attention
- **IF IN EYES:** Bathe the eye with running water for 15 minutes. Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention. Remove contact lenses if possible and safe to do so
- **IF SWALLOWED:** Rinse mouth. Do NOT induce vomiting. Wash out mouth with water. If conscious, give half a litre of water to drink immediately. Transfer to hospital as soon as possible
- **IF INHALED:** Remove victim to fresh air and keep at rest in a position comfortable for breathing. If feeling unwell, call for medical assistance
